Overview

Twilio Inc.'s ("Twilio") Programmable Voice offering ("Voice"), including Programmable Call Recordings ("Recordings"), is Payment Card Industry Data Security Standard (PCI DSS) Level 1 Service Provider compliant. The Twilio Voice API gives developers programmatic control over their calls, with APIs built for a wide variety of uses from basic phone to phone calling, app to phone calling, Interactive Voice Response (IVR), conference calling, SIP interfacing, call recording (includes option to store recordings in AWS S3 buckets with S3 server-side AES-256 encryption enabled), transcription, call tracking, and more. Twilio's customers can build a customizable payment solution to process or transmit cardholder data using Twilio Voice on Twilio's secure, trusted and PCI-certified platform. Customers can manage the settings associated with their Voice implementation via Twilio's <u>customer console</u> ("Console").

The following table shows the responsibilities of Twilio and their customers to fully meet PCI DSS compliance. *Some PCI DSS requirements are fully the responsibility of Twilio customers to implement to meet PCI DSS compliance.*

Purpose

This responsibility matrix documents how PCI DSS responsibilities are shared between Twilio and customers using Twilio's Programmable Voice services.
